10.1 SELGA President’s Report

Mayor Erika Vickery highlighted a number of meetings attended on behalf of SELGA.

10.2 SELGA Executive Officer’s Report

Ann Aldersey tabled a written report, and highlighted the focus on briefing all Constituent Councils, working with the staff to prepare business plan, budget and project work plans for 2015-16, and moving into the

implementation phase of the Regional Planning Alliance and Regional Trails Master Plan projects.

10.3 Local Government Association of SA

Lisa Teburea, Director of Planning and Community Services provided a summary of the process to recruit a CEO of the LGA following the resignation of Wendy Campana.

The State Government has provided a response to the Planning Reform Recommendations, supporting (in part or in full) 22 of the recommendations. There is further opportunity for the South East to be a pilot region.

10.4 Office of Local Government

Ms Alex Hart, Acting Manager Office of Local Government, Department of Planning, Transport and Infrastructure

- Short term legislative reform is continuing with the preparation of a bill to go to parliament in May-June, in particular proposing changes to the Conflict of Interest provisions, Code of Conduct for elected members and employees.
- Longer term legislative reform in 2016 is being driven by the Premier-State and Local Government Forum, and is keen to seek input on regional arrangements.

10.4 Report from Tourism Development Officer

Biddie Shearing, Tourism Development Officer, RDA Limestone Coast spoke to her reporting, highlighting the success of the recent Limestone Coast Collaborative Forum, applications for regional events and festivals, and the Discover SA trade event which netted a number of trade bookings to the Limestone Coast.

10.5 Report from SELGA Starclub Field Officer

Tony Elletson, Starclub Field Officer spoke to his report, and in particular his focus on supporting clubs to achieve all the legal requirements that clubs need to meet. In 7 weeks in the role, Tony has met with over 30 clubs to date, supporting in seeking grants, completing the Starclub program and providing training.
