The Audit and Risk Committee is a committee established to provide the LCLGA Board and Executive Officer with advice and recommendations to improve the LCLGA's overall performance, including corporate and financial governance, business risks and legal compliance.

The Terms of Reference for the Audit and Risk Committee have been under review and were presented to the Audit and Risk Committee meeting held on the 21 March 2024 and then to the LCLGA Board meeting held on the 19 April 2024.

At the LCLGA Board meeting held on the 19 April 2024 the Terms of Reference for the Audit and Risk Committee were deferred to the next Board meeting based on further information from District Council of Grant.

These Terms of Reference for the Audit and Risk Committee have never been represented to any Board meeting since April 2024, with staffing issues over the last 6 months the Terms of Reference have not been looked at.

The Audit and Risk Committee membership that was in place last year consisted of Mayor Martin, City of Mount Gambier, Mayor Noll, Wattle Range Council, Sarah Philpott CEO City of Mount Gambier and Paul Duka, Director Corporate Services Wattle Range Council.

When Mayor Noll resigned from the LCLGA Board he was never replaced on the committee and there was some rumblings amongst the Board in relation to City of Mount Gambier and Wattle Range Council as the only Council's on the Audit and Risk Committee, subsequently Sarah Philpott resigned from the committee.

With the changes in staff and direction these 2 committee positions were never filled and therefore the committee has not had a quorum and has not met since April 2024.

Any financial requirement of the Local Government Act i.e. Annual Business Plan, Budget , Budget Reviews have been directed straight to the LCLGA Board for approval.

As the reviewed Terms of Reference have not been adopted by the Board, the existing Terms of Reference for the Audit and Risk Committee will need to be used in obtaining membership for the committee at the Annual General Meeting.

Therefore, the membership of the Audit and Risk Committee is 5 members:

- 2 - Representatives of the LCLGA Board
- 2 – Representatives who are CEO's or Executive from member Council's
- 1 – Independent member who is not from Local Government

The President of the LCLGA shall be ex-officio member of the Committee  
To date there has not been an independent member on the Audit and Risk Committee.
